Product will burn under fire conditions. Vapors may travel a considerable distance to a source of ignition and flash back along vapor trail. Under fire conditions, toxic, corrosive fumes are emitted. Reacts with water releasing large amounts of carbon dioxide which may cause pressure build-up in confined spaces.

<<<<< SECTION 6 - ACCIDENTAL RELEASE MEASURES >>>>>

STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED:

Evacuate all non-essential personnel. Remove all sources of ignition. Ventilate the area. Equip employees with appropriate protective equipment. Dike around spilled material. Cover spill with inert absorbent material and shovel with nonsparking tools into container. Remove containers to a safe area and seal.

PRECAUTIONS TO BE TAKEN IN HANDLING and STORING:

"Empty" containers retain residue and can be dangerous. Do Not pressurize, cut, weld, braze, solder, drill, grind, or expose such containers to heat, flame, sparks, static electricity, or other sources of ignition - They may explode and cause injury or death.

All equipment should be grounded and bonded to reduce static electricity hazard. Use non-sparking tools.
